**Report on day's Events:** (Backstretch - accidents, fines, suspensions, objections, disqualifications, refunds, pertinent incidents, general details etc., Film Reviews, Races, Claims)

### Backstretch:

Call from Security Manager Tanya Bailey, S/O Michael Gage, license declared invalid, no longer employed. Ruling generated

Paddock Judge Harry Eder called to inform that trainer Robert Warner, 4th race #1 Chiefroll'nthunder had entered with Blinkers off and Cheek piece on, cannot locate cheek piece and wished to have Blinkers back on. The request is denied by the Stewards as per TB Rule 16.10 must be declared at time of entry. Trainer must have the equipment available for racing.

Call from Chief Test Inspector Meaghan McGirr, Medication Admin. Report (MAR) omitted the horse Flatoutonamission from the printout and did not receive the medication Furosemide at the required time resulting in the horse being scratched by the Stewards from the 7<sup>th</sup> race. A report from the Test Barn is to follow. Trainer Sandra Dominquez was informed.

Spoke with Clerk of Scales, TV feed to Jockeys quarters is to be fixed and completed on Thursday June 25, 2020.

**Film Reviews:**

No tv monitors operational in the Jockey's quarters, issue with the fiber optic cable, educational reviews and caution issued to Melanie Pinto and Howard Newell for using their crop in the upward position when making contact with their mount.

Race 7 June 16, 2020. Marklee Buchanan possible urging violation, excessive, more than three strikes in succession, film inconclusive as he may not have made contact with the first. No penalty issued.
