Race 5, reviewed run into the 1st turn regarding #3 Le Grand Garcon, J. Alderson, 3rd and #4 Mister Meseeks, #4 appeared to lay in on #3 and Alderson did steady a stride, call to S. Jadoo to ensure he leaves room to the inside horses.

Race 6, Turf, late Veterinarian scratch of #5 It's Pay Day, J. Reyes, reared in gate, Jockey claim of foul, #2 L. Salles aboard Our Lilly, 4th on #1 D. Gaskin aboard Blue's Mommy, 3rd after the start, upon review of front tower and upper pan camera angles, #1 does outbreak #2 and does come out slightly, is corrected quickly but outside pressure diminished the room for #2, claim of foul disallowed, #3 J.
