Race 1, #1 Kowboys Sequel reared up in the gate prior to start and popped the gate stall doors open, the handler contained the horse for a moment but could not hold on as the horse lunged forward unseating Jockey Melanie Pinto and running off, was a subsequent Steward scratch. Refund of \$13,119. Race All clear

Race 2, #3 Canadian Daddy reared up in the gate, and on advisement of the Official Veterinarian, the horse be scratched, refund of \$11,084. Race All clear.

Race 3, #6 Nicole's Song, Alexis Sanchez bore out into stretch run, rest ok

Race 4, Off turf, #3 Daisycrest, I Mosqueira, 5th off a step slow and threw head up after start, rest good.

Race 5, #6, Taylormoon reared in gate, popped open the doors, ran off a 1/16th mile, was caught by Course Marshall, on advisement of the Official Veterinarian the horse was scratched, refund of \$28,546. #2 Mimi's Holiday, A. Vandermeersch, 3rd, off a step slow, rest good.
