Race 1, #2 Princessonamission, D. Bynoe, 5th, stumbled at the start, #1 Grand Warrior, S. Vives, 1st lugged out throughout the race. Rest ok. Princessonamission was beaten 37 ½ lengths.

Race 2, Slight delay, Jockey Mosqueira injured in the gate, EMS attended, off remainder of mounts, slight delay as the horse returned to the paddock to acquire another rider. Jockey Michael David was acquired for the horse, #5 Stirling Castle, D. Gaskin, 2nd, bore in at start making contact with #4 Forest Flash, H. Vanek, 5th, #4 did not appear to be hindered by the contact, rest ok. Jockey Brian Cheyne excused from the remainder of his mounts.
